Admission Notice for Balvatika Classes I and II for Session 2023-24

Online registration for Admission to Balvatika Classes in Kendriya Vidyalaya Cossipore for the Academic Year 2023-24 will commence from 03-04-2023 and will close at **02:00 PM on 12-04-2023**. Interested parents are requested to apply using the given links strictly before the close of the deadline.

- Fresh Admission shall be done as per Service Priority and reservation given in the revised KVS admission Guidelines 2023-24 and age criteria for candidates is as under:

Balvatika - I (Attained 3 years but not completed 4 years as on 31st March 2023)

Balvatika - II (Attained 4 years but not completed 5 years as on 31st March 2023) **Only few seats**

- Reservations under the provisions of **RTE Act-2009** shall be **applicable only for Balvatika – I**. (**provisions of RTE Act-2009 shall not be applicable for Balvatika – II**)
- Provision for admission under **Single Girl Child Category** shall **not be applicable** to these classes.
- Original and a copy of the following documents are required to be presented to the school at the time of **admission if offered**:
 1. Proof of Date of Birth of the child.
 2. Passport Size Photo of the Child
 3. Proof of Residence (Electricity Bill/ Gas Connection Blue book/ Telephone Bill/ Passport/ Bank Passbook/Driving License/Tenant agreement etc.) along with Self Declaration Format available on above link
 4. Proof of Occupation if applicable (For Central/State Govt Employees and various Undertakings under Central/State Govt)
 5. Transfer Certificate from the Competent Authority mentioning the details of postings in last 7 years if applicable (For Central/State Govt Employees and various Undertakings under Central/State Govt)
 6. Caste Certificate if applicable (Note: In case of unavailability of caste certificate of child, father's caste certificate must be uploaded. Only in case of single Mother, Mother's caste certificate will be accepted. OBC Certificate issued on/after 2019 will only be accepted.)
 7. Certificate of Differently abled from the Competent Authority if applicable
